- Ratings Thanks to Rex Daubenberger, Harry Bicchieri, and Bruce Coulter, last year's Rating Committee. This year's Committee is Patty True, Chairperson, with Karen Kishbaugh, Jan Golden, Jerry Strom, Keith Ori on the committee.
  - 3 step procedure for getting re-rated
    - Ladder This will be segregated by men and women if numbers allow. Each session will be 5 weeks and members must play 4 games within those 5 weeks to qualify. There will be 4 to a court playing 3 games to 15 in a round robin format. The committee will determine a pre-determined average to allow members to move to a skills assessment after the 5 weeks. There will be no limit on number of members allowed to move up to skills assessment. More detail to follow.
    - Skills Assessment two members wishing to be re-rated will play against two 3.5 or better rated players to assess skills needed for the higher rating. Members will be given these expectations prior to the assessment and ladder participation. The higher members will be there only to provide the rerating members an opportunity to show their skills. For example, a rerating member may need to dink and a higher rated player has the control to get the ball to the rerating member so he or she has the opportunity to show the skill. 3.5 or higher volunteers will be needed to play.
    - Probation if successful, member will move to next level on a 1-3 month probationary period with rating committee and peers assessing their play to determine if skills are at the new level.
